1. Promoter Information

3.1 The Promotion begins at 12:01 AM New Zealand Time on 1 April 2024 and ends at 11:59 PM on 31 May 2024 ("Promotion Period").

4. Eligibility Criteria

4.1 This Promotion is open to the following persons ("Participants"):

- (a) Permanent residents of New Zealand who are aged 18 years of age or older.
- (b) Persons who during the Promotion Period enter into a conditional "Full Build" contract with the Promoter for the construction of a dwelling within the specified territory of the Promoter under the Latitude Homes brand to a fully completed stage and which contract subsequently becomes unconditional and payment for which is made in full by the Participant.
- (c) There is only to be one Participant for each conditional Building Contract who is eligible for the Promotion.

4.2 For the purposes of satisfying the Eligibility Criteria, a "Full Build" contract excludes any contract for the supply by the Promoter under the Latitude Homes brand of either a kitset dwelling or a shell only dwelling or a shell internal only dwelling.

4.3 Employees, Contractors and their immediate families (including partners, siblings, grandparents, parents, children and grandchildren of any of the Promoters) are not eligible for the Promotion.

- 5.6 Ineligibility due to any breach of terms results in forfeiture of the travel voucher.
- 5.7 The travel voucher will be provided upon the Promoter's receipt of the selected recipient's payment in full of all monies under the relevant unconditional Building Contract.
